BECOMING A BALUCHONNEUSE

The steps of our selection process

As you know, at Baluchon we are committed to providing high-quality service. This is why we pay particular attention to recruiting our team of respite care workers. They are the ones who work directly with families. It's a unique and rewarding experience, but one that also carries significant responsibility.

To find the right people for this role, we have developed a rigorous recruitment process. Selected candidates go through several steps, including situational judgment tests and personality assessments. Multiple interviews with members of the management team round out this process, which is uncommon for a non-profit organization like Baluchon.

Why do we invest so much in this process?

Because being a respite care worker (baluchonneuse) is emotionally, physically, and professionally demanding. We do not want to place just anyone in a difficult situation. That is why we take the time to recruit individuals who are adaptable, proactive, and emotionally stable. New recruits then receive several theoretical and practical training sessions relevant to the responsibilities of a respite worker.

PORTRAIT OF A BALUCHONNEUSE

Meeting with Susan Benoit



Coming from a military family, I was born in Manitoba and moved to Quebec at the age of five. I continued my studies while working until I was 28, when I finally settled into a veterinary clinic that some friends were opening. Needless to say, as the only employee supporting two veterinarians, I had to wear many hats: customer service, administration, assisting in surgery and care, and the list goes on.

When the clinic was sold, after I had given it my all for 32 years, I decided to leave because it no longer aligned with my needs. It was a heartbreaking decision. I walked the Camino de Santiago to clear my mind. When I returned, I knew I wanted to work in counselling with adults. I needed a flexible job that still allowed me to feel fulfilled. I didn't go looking for anything; I just waited for a miracle... and it happened. I met a passionate respite worker and immediately knew this was the second career I had been searching for. The very next day, I sent in my application, was hired, and joined the cohort that was just beginning its training.

At first, each visit felt harder than the one before, until the day I finally felt like I belonged. Now, I'm able to turn challenges into meaningful, positive experiences. I love adapting to each family I visit. The cultural exchanges I get to experience across our beautiful province are truly enriching to me as a person. In the end, I truly believe I receive just as much as the caregivers I support.

Susan has quite a personality. Her empathy and gentleness, paired with her strength and remarkable perseverance, make her a born caregiver who is deeply appreciated by families. We are very lucky to have you with us, Susan. The whole team warmly thanks you for your commitment to caregivers!



ANOTHER WAY TO SUPPORT BALUCHON

Testimony from François Gauvin, also a member of the Foundation's Board of Directors



Can you introduce yourself in a few words (profession, connection to the NPO)?

My name is François Gauvin.

I am a CPA with experience in taxation and private investments.

I'm a member of the Board of Directors of the Baluchon Foundation



What motivated you to make a donation, and more specifically a share donation?

Baluchon is an extraordinary organization that offers respite services to caregivers, an essential support for many people in Quebec. With demographic changes on the horizon, the need for such services will only continue to grow.

Donating shares is a simple process and can often be more tax-efficient for the donor, especially when the shares have a lower cost base than their fair market value at the time of the donation.



Were you familiar with the concept of donating shares before you made your own donation?

Yes, it's a concept that has been around for a long time.



How did you find out how to make this type of donation, and did you have any assistance (accountant, financial advisor, our team) in doing so?

No professional assistance was required. All you have to do is contact your broker, who will send you a form authorizing the transfer of shares from your brokerage account to the organization's account. Of course, you must first obtain the organization's brokerage account details. Once the form is submitted to your broker, the transfer is generally completed within two to four business days.



What role do you think share donations can play in the mission of the nonprofit?

Share donations play exactly the same role as cash donations. Once the organization has sold the shares on the public market, it can use the proceeds from the sale just as it would a cash donation.



What would you say to someone who is hesitant to donate shares?

There's no reason to hesitate, especially if the shares in question have a tax cost basis that is lower than their fair market value (FMV).



Do you have a message to share with potential donors?

Baluchon is a wonderful organization! No matter how you choose to donate, Baluchon will use your contribution to provide much-needed respite for caregivers!
